- SAPS Competency certificate (front and back if white card type or A4 printout received from the SAPS)

- Particulars of Current Owner – please provide one of the following:
 - New firearm from dealer: SAPS271 - Application for License to Possess a Firearm
 - Private sale: certified copy of the private sellers' ID and license, front and back (if white card type) *(Very important, If the Private Owner's licence card has expired, you must first confirm with your local DFO whether they will accept an application for an expired licence)*
 - Estate:
 - Certified copy of the Letter of Executorship.
 - Certified copy of ID document of Executor and Executors letter.
 - Transfer letter from Executor stating that the applicant is the heir of the firearm.
 - Alternatively, if not the heir, that the heir is not interested in the firearm.
 - Certified copy of the deceased's death certificate and ID document.
 - Copy of deceased's firearm licence card (front and back, if white card type), if available

- Most recent confirmation of membership certificate, should you belong to a club/association.
- Dedicated hunter/sport shooter certificate, if you already own more than 4 firearms.
- Case numbers, if you have.
- Newspaper clippings of crime in your area, if available.
