Our Services: Ranyati Firearm Motivations originated in 2006 and we have put together over 18000 plus successful applications. Our purpose is to provide a one-stop service regarding the administration of the Firearms Control Act. We would like to make it simpler for the general public to comply with the requirements of the Act. We prepare a motivation on your behalf. Each motivation consists of all the reasons to counter the reasons used by the Central Firearm Registry (CFR) in the past to refuse an application, as well as your supporting documentation required by the police which get thoroughly checked by our office. The completed motivation with the relevant supporting documents is printed and bound in a book form. You submit the document (approximately 30 pages) together with your application form to your Designated Firearms Officer (DFO) situated in the area where you ordinarily reside. **We take approximately 7 to 10 working days to complete a motivation.**

Our Fees: Please tick below which services you would like to make use of:

- Motivation – R920:** Our fees are R920 per firearm.
- Motivation within 72 Hours – R1150:** Our fees are R1380 per motivation, per firearm. This service is only available from Monday to Friday.
- Motivation within 24 Hours – R1380:** Our fees are R1380 per motivation, per firearm. This service is only available from Monday to Friday.
- Competency Application Form – R405:** Our fees are R405. We complete the Competency Application form (SAPS517 or SAPS517A) on your behalf. The completed competency application with the relevant supporting documents is printed and bound in a book form.
- Completion of SAPS271 Licence or SAPS518 Temporary Authorization Application form(s) – R405:** Our fees are R405 per application form. *For the completion of the Application form(s) we require the original signed copy from the Private Owner, Estate or Firearm Dealer.*
- Reviewing of completed application form(s) – R175:** Our fees are R175 per completed SAPS application form. The client completes the SAPS application form and we will verify the correctness thereof. *Please note; this fee is not applicable to a motivation written by yourself and/or a different company, only for completed application forms.*
- Courier Services – R200 / R250:** Courier Services are available at R200 for deliveries within Gauteng and R250 for deliveries outside of Gauteng. Please note: No courier services to farms & post boxes are available; The couriers are not operational over weekends; The courier service is not available to the 24 Hour service; & The courier service fee is subject to surcharges that may in rare instances be charged by our courier supplier themselves.
- Reprint and collating of an existing Ranyati motivation – R405:** Our fees are R405 per motivation. We print and bind your complete motivation and supporting documents as per how you received it previously. The motivation and all supporting documentation get reviewed again to insure everything is correct and up to date. *NB: Not applicable to motivations older than a year.*
- Appeal – R4025:** The fee is R4025 per appeal, per firearm – We make use of Clark Attorneys for our appeals. You pay the fee directly to our bank account, after which we will accordingly pay the fees across to Clark Attorneys and liaise on your behalf with the lawyers. *This service is only applicable if your original motivation was done through Ranyati Firearm Motivations.*
